This document constitutes the Privacy Notice pursuant to the provisions of the Federal Law on the Protection of Personal Data Held by Private Parties and any applicable regulations deriving from or related to it.

1. DEFINITIONS

This document constitutes the Privacy Notice pursuant to the provisions of the Federal Law on the Protection of Personal Data Held by Private Parties and any applicable regulations deriving from or related to it.

- a) Privacy Notice: A physical or electronic document generated by the Controller, made available to the Data Subject prior to the processing of their personal data.
- b) Personal Data: Any information concerning an identified or identifiable natural person.
- c) Sensitive Personal Data: Personal data that affects the most intimate sphere of its Data Subject or whose misuse could result in discrimination or serious risk.
- d) ARCO Rights: The rights of Access, Rectification, Cancellation, and Opposition as provided by the Law.

Access: The right to know what personal data is held and to whom it has been shared.

Rectification: The right to correct inaccurate or incomplete data.
Cancellation: The right to request the deletion of data once the legal or contractual retention period has ended.

Cancellation: The right to request the deletion of data once the legal or contractual retention period has ended.

Opposition: The right to request that data processing cease for legitimate reasons.

e) Controller: The individual or legal entity that decides on the processing of personal data, in this case, the companies of GRUPOMAR.

f) Processor: The individual or legal entity that processes personal data on behalf of the Controller.

g) Data Subject: The natural person to whom the personal data refers.

2. DATA SUBJECT'S CONSENT

The Data Subject acknowledges that: (i) this Privacy Notice has been provided by the Controller; (ii) they have read, understood, and agreed to its terms, thus granting consent for the processing of their data; and (iii) consent is also given for GRUPOMAR or its Processors to transfer personal data to third parties, domestic or foreign, provided such processing adheres to this Privacy Notice.

If the Data Subject does not object within 48 hours after this Notice is made available, it will be deemed accepted. Consent may be withdrawn at any time without retroactive effects.

3. PURPOSE OF DATA PROCESSING

The purpose of this Privacy Notice is to establish the terms under which GRUPOMAR will receive, use, protect, and, where applicable, transfer personal data.

The Controller may collect data through printed or digital means, such as: full name, date of birth, marital status, nationality, address, phone numbers, email, RFC, CURP, bank information, IMSS number, and similar.

Personal data may also be collected from public or third-party sources.

Main purposes:

- a) To maintain or initiate a commercial or employment relationship.
- b) To comply with legal obligations and manage business risks.

GRUPOMAR may share data with service providers for database administration, recruitment, auditing, and similar purposes.

4. USE OF COOKIES

GRUPOMAR websites use cookies to ensure proper functionality. Cookies are small data files stored on your device that can be temporary (session cookies) or permanent. You may adjust your browser settings to reject cookies, but doing so may limit website functionality.

Emails containing links may allow GRUPOMAR to know if the recipient visited a specific page, and such information may be added to user profiles.

5. DATA TRANSFERS

By accepting this Notice, the Data Subject authorizes GRUPOMAR and its Processors to transfer personal data to third parties, domestic or foreign, ensuring such third parties handle the data in accordance with this Privacy Notice.

No consent is required for data transfers covered under Article 37 of the Law or any other applicable legal exception.

6. DATA RETENTION AND SECURITY

The Controller and/or Processors will keep personal data for as long as necessary to process requests, maintain records, or comply with accounting, tax, and legal obligations.

Data will be safeguarded with administrative, technical, and physical security measures. However, GRUPOMAR cannot guarantee that unauthorized third parties will not gain access to data; therefore, it shall not be liable for damages arising from such unauthorized access.

7. PROCEDURE TO EXERCISE ARCO RIGHTS

To exercise Access, Rectification, Cancellation, or Opposition rights, the Data Subject or their representative must send a written request including:

- Name and contact details;
- Proof of identity (official ID) or legal representation;
- Clear description of the personal data and the right to be exercised; and
- Any information that helps locate the data.
